

Executive Summary

Private Equity⁽¹⁾ Investments & Exits

February 2023 registered 50 Private Equity (PE) investments worth about ₹8,368 crore (\$1.01 Billion).

The largest PE funding deal announced during the month was the ₹1,200 crore (\$144.7 million) investment by Multiples PE and State Bank of India in Murugappa Group's EV unit **TI Clean Mobility**.

Investment firms with AIF vehicles participated in 28 PE investments (~56% of the overall).

The IT & ITES industry topped the industry table by value and volume.

Chennai topped the chart for the highest investments in a city.

The month witnessed 10 PE exits that harvested about ₹4,965 Cr (\$601 million).

Venture Capital (1) Investments & Exits

February 2023 registered 35 Venture Capital (VC) investments worth about ₹1,613 crore (\$195 million).

The largest VC deal were the \$20 million investment each in electric vehicle (EV) fleet operator **Zypp Electric** and in commerce enablement platform for MSMEs **Mintoak**.

VC firms with AIF vehicles participated in 19 investments (i.e., in over 54% of the overall number of VC deals).

28 DPIIT-registered startups raised \$168 million during the month (i.e., 80% of the overall number of VC deals).

The IT & ITeS industry topped the industry table, both by volume and value.

NCR Delhi topped the chart for the highest number of investments in a city.


The month witnessed 4 VC exits that harvested about ₹545 crore (\$66 million).

Angel Investments

Angel Networks & Super Angels made 28 investments in February 2023.

The largest funding deal involving angel investors was the \$20 million investment in electric vehicle (EV) fleet operator **Zypp Electric**, which saw participation of Indian Angel Network, Venture Catalysts Angels, LetsVenture, We Founder Circle, IVY Growth Associates and others.

Private Equity Investments



Private Equity Investments in February 2023: 50 Deals, \$1.01 Billion (₹8,368 crore)

February 2023 registered 50 Private Equity (PE) investments worth about ₹8,368 crore (\$1.01 Billion).


The largest funding deal announced during the period was the ₹1,200 crore (\$144.7 million) investment by Multiples PE and State Bank of India in Murugappa Group's EV unit **TI Clean Mobility**.

The second largest PE deal was the ₹862 crore (\$104 million) investment by Amazon Smbhav Venture Fund, E20 Investment Ltd, Mount Judi Ventures, Dallah Albaraka and existing investors in D2C online meat seller **FreshToHome**.

The third largest were the ₹825 crore (\$100 million) acquisition of smart metering firm **Gram Power** by I Squared Capital and an investment in fintech major **PhonePe** by Ribbit Capital, Tiger Global and TVS Capital Funds.

Funds with AIF vehicles participated in 28 PE investments worth ₹5,327 crore (\$645 million). The largest deal involving firms with AIF vehicles included the investments in **TI Clean Mobility** (by **Multiples PE**) and **FreshToHome** (by **Mount Judi Ventures, Iron Pillar, InvestCorp Group, Ascent Capital**).

By Industry



The **IT & ITES** industry topped the industry chart with funding worth \$617 million (₹5,043 crore) led by the investment in **Freshtohome**, followed by the \$100 million (₹825 crore) investment each in **Gram Power** and **PhonePe**.


The **Manufacturing** industry came second attracting funding worth \$176 million (₹1,436 crore), led by the investment in **TI Clean Mobility**.

The **Travel & Transport** industry came third with \$95 million investment in publicly listed SpiceJet by Carlyle (SpiceJet's lessor) in the form of conversion of its outstanding lease rental into equity.



Venture Capital Investments in February 2023: 35 Deals, \$195 Million (₹1,613 Cr)


February 2023 recorded 35 VC-type investments* worth \$195 million (₹1,613 crore). (*See Appendix for Venture Capital definition).


The largest VC investment during the period were the \$20 million investment each in electric vehicle (EV) fleet operator **Zypp Electric** (led by Taiwanese EV maker and battery-swapping company Gogoro) and in commerce enablement platform for MSMEs **Mintoak** (led by PayPal Ventures with participation from British International Investment or BII and existing investors).

The second largest was the \$17 million Series A investment in drone startup **Garuda Aerospace** led by VC firm SphitiCap along with Canada-based Ocgrow Ventures and UK-based Silverstone Capital.

Funds with AIF vehicles participated in 19 VC investments worth \$120 million (₹993 crore).

28 DPIIT-registered startups raised \$168 million (₹1,388 crore). The largest VC funding rounds raised by DPIIT registered startups included those by **Mintoak**, **Zypp Electric**, **Garuda Aerospace** and commercial EV platform **Turno**.



Private Equity Exits in February 2023: 10 Deals, \$601 million (₹4,965 crore)


February 2023 saw 10 PE exits that harvested ₹4,965 crore (\$601 million). The top exits during the period included companies from the IT & ITES, BFSI and Shipping & Logistics industries.

Sale of shares worth ₹2,430 crore (\$293.83 million) by Baring Asia and ₹1,378 crore (\$166.95 million) by Alibaba in publicly listed **Coforge Ltd.** (formerly **NIIT Technologies Ltd.**) and in **One97 Communications Ltd** (which owns **PayTM**) respectively were the top PE exits during the period.


Venture Capital Exits



Venture Capital Exits in February 2023: 4 Deals, \$66 million (₹545 crore)

February 2023 saw 4 VC exits that harvested ₹545 crore (\$66 million).

The largest VC exit was the ₹449.86 crore (\$54.51 million) complete exit by SIDBI VC, Bellwether, India Financial Inclusion Fund and other existing investors in **Sonata Finance** - a NBFC micro finance institution (NBFC-MFI) - via a strategic sale to Kotak Mahindra Bank.




*Investments by super angels & angel networks

In February 2023, super angels and angel networks made 28 investments.

The largest funding deal involving angel investors was the \$20 million investment in electric vehicle (EV) fleet operator **Zypp Electric**, which saw participation of Indian Angel Network, Venture Catalysts Angels, LetsVenture, We Founder Circle, IVY Growth Associates and others.

Appendix - Definitions of Stages Used

Venture Capital:

Early Stage

First / Second Round of institutional investments into companies that are: Less than five years old, AND Not part of a larger business group, AND Investment amount is less than \$20 M

Growth Stage:

Third / Fourth Round funding of institutional investments OR First/Second Round of institutional investments for companies that are >5 years old and <10 years old OR spin-outs from larger businesses, AND Investment amount is less than \$20 M

Private Equity:

PE investment figures in this report include Venture Capital (VC) type investments but exclude PE investments in Real Estate.

Growth-PE:

First-to-Fourth Round Investments >\$20 M into companies <10 years old, OR Fifth / Sixth rounds of institutional investments into companies <10 years old

Late Stage:

Investment into companies that are over 10 years old, OR Seventh or later rounds of institutional investments


PIPEs:

PE investments in publicly-listed companies via preferential allotments / private placements,

Acquisition of shares by PE firms via the secondary market

Buyout:

Acquisition of controlling stake via purchase of stakes of existing shareholders
